Discussion on the Gaslight BAN renewal for July 9th. Bank of Castile and Five Star Bank declined to bid on the \$24,000 BAN renewal. Steuben Trust gave a rate of 2.9%. Trustee Smith made a motion to renew the Gaslight BAN for \$24,000 with Steuben Trust. Trustee Smart seconded. All in favor. Motion carried.

Bill Neal requested the Village send a letter to Morgan Stanley that the Village Hall is not affiliated with the Village of Wyoming. Trustee Lacey made a motion to send a letter to Morgan Stanley regarding the Village Hall. Trustee Smart seconded. All in favor. Motion carried.

Received a letter from The Verdin Company regarding a Planned Maintenance Agreement for the clock on the green. The cost would be \$580.00 per year. It was decided not to do the Agreement.

Superintendent, Ben Welch, reported he will install an exhaust fan and a dehumidifier in the Park Building. The backhoe is getting fixed. Moving forward with the gaslights, National Fuel will be doing three (3) a day. Sidewalk in the park should be started in June or July. Garbage cans have been ordered. Swing set to get painted and pea stone will be approximately \$881.00.

Discussion on 164 Main Street.
