### The Gas Light Restoration Project Update:

All of the gaslights are in place now and will be finished just as soon as Ben finishes locating water lines and service turnoffs for the water project.

The Village of Wyoming was chosen for the **“2019 New York State Historic Preservation Award”** for Gas Light Restoration Project. The Village of Wyoming was recognized with this consideration from all other historic preservation projects in New York State. This project would have never been completed in whole if it wasn't for NYS Senator Patrick Gallivan helping to get a \$64,956 grant from New York State. The letter of notification is included in this envelope.

### Water Project Update:

The new well was done this week with abundant amount of water like we had hoped. The water line is full of water and chlorine to disinfect everything so the waterline will pass inspection.

The contractors will be starting to hookup the service lines next week, this will take close to a month. We sent out a letter earlier this week with Rural Development information just in case you need a new service line and possibly need assistance. Make sure you look over the paperwork before calling.
