Trustee Smart made a motion to add Mayor, Scott Hudson to the Village's accounts with Community Band and NYCLASS. Trustee Bush seconded. All in favor. Motion carried.

Andrew Kruetter received a Zoning Permit to extend the building at 164 Main Street in the Village of Wyoming. Trustee Lacey made a motion to approve the Zoning Permit. Trustee Bush seconded. All in favor. Motion carried.

Discussion on Zoning Officer and Comprehensive Plan. Scott McCumiskey is interested in the Zoning Officer Position. Trustee Smart made a motion to appoint Scott McCumiskey as Zoning Officer. Trustee Bush seconded. All in favor. Motion carried. Trustee Lacey made a motion to budget \$2,165.67 annually for the Zoning Officer position. Trustee Heale seconded. All in favor. Motion carried.

Jody Breslin was present representing the Planning Board. It was mentioned doing postcards for the Public Hearing regarding the Comprehensive Plan. Clerk mentioned at the March Village Board meeting, the Board decided to do a Public Notice for the Public Hearing instead of doing post cards.

All in favor. Motion carried. The generator has been installed at the School Road pump house. The propane tank is scheduled to be installed on Friday, May 12th. Discussion on mowing the Fire Hall property. Lead and Copper water testing is due this Quarter. Ordered stone for School Road. Mulching needs to be done.
