Superintendent, Al, reported he has 49 Banners to put up this year. Frontier Telephone damaged a tree on Main Street due to mowing. Al did notify Frontier Telephone of the damage done to the tree. Tree on Maple Street has been taken down. The County did come out to put up a Pedestrian Sign on School Rd. Sherman Avenue and Maple Street both need crack sealer.
