Justa Goodell was present to discuss the leash law and dog licenses in the Village. Also, discussion on chickens in the Village. Chickens are allowed on properties that are zoned agriculture but not on properties zoned residential. Trustee Lacey made a motion not to have chickens on residential properties.
